

RE: Pasadena Area Community College District Issues Survey Summary of Key Results

DATE: April 23, 2016

• A recent survey¹ of 822 Pasadena Area Community College District voters likely to cast a ballot in the November 2016 General Election shows that if an election were held at the time of the survey, 65 percent of respondents would definitely or probably vote "yes" in favor of a \$888 million bond measure to fund repairs and upgrades to District facilities, with another six percent leaning toward voting yes. Additionally, just 20 percent would either definitely, probably or lean towards voting "no" to oppose the measure. A further nine percent were initially undecided on this 55% threshold measure. ¹ Between April 3-11, 2016, Fairbank, Maslin, Maullin, Metz & Associates (FM3) conducted a telephone survey (landlines and cell phones) of 822 Pasadena Area Community College District voters likely to vote in the 2016 California General Election. The margin of error for the full sample is +/- 3.7% and for half the sample it is +/-4.8%; the margin of error for subgroups will be higher.

• High percentages of respondents (60% or more) rated a number of features and provisions to be included in the measure as extremely or very important (see Table 1). The highest rated features/provisions include preparing students to transfer to four-year colleges and universities, ensuring all classrooms and buildings meet California earthquake standards, and requiring that all funds be used locally.

- Seven in ten respondents (71 percent) said that they would be more inclined to support the measure after hearing that it would include strict accountability requirements including a Citizens' Oversight Committee, independent financial and performance audits, no money going toward administrators' salaries or pensions, and all funds staying local.
- Three-quarters or more said they would be more inclined to vote "yes" in support of the measure after hearing the following statements/provisions which indicate the proposed measure will:
 - > Improve educational opportunities for returning veterans (81% more inclined to vote yes);
 - ➤ Offer affordable education that prepares students for transfers to UC and Cal State schools (77%) and;
 - ➤ Provide critical career technical and vocational education to prepare for in-demand careers in nursing, healthcare, business, engineering and other high-paying 21st Century jobs (75%).
- Almost two-thirds (65 percent) agree that "Pasadena City College is well-run and serves our community's needs." (See Figure 2.)
