



Subject: Board of Trustees meeting report, June 7, 2017

Hello:

In an effort to help the campus community stay informed about actions taken during governance meetings, I'm pleased to share a report from last night's Board of Trustees meeting.

- Emily Ekshian was sworn in as the student trustee for the 2017-18 academic year, taking the place of Nune Garipian.



- Ms. Garipian was recognized by the board for her service, and she was presented with an honorary plaque commemorating the event. In his remarks as he delivered the honor, Superintendent-President Vurdien highlighted Garipian's "composure, articulation, and dedication," and he and the board thanked her deeply for her service.



- The board recognized the PCC women's badminton team, which recently claimed its first CCCAA state championship. Coach Jen Ho introduced the undefeated team and complimented them on their performance and dedication to their sport.



- Vivian Chan and members of the Parent, Teacher, and Student Association presented a donation of \$3,000 to the Lancer Pantry to fund the purchase of a commercial refrigerator at the college's food bank. The pantry has served more than 1,300 students since opening in December. Chan said the donation was intended to encourage healthy eating habits among PCC's student population.



- In his presentation on the district's tentative 2017-18 budget, Richard Storti, PCC's assistant superintendent/vice president for business and administrative services, unveiled a plan to exactly match expenditures to revenues and produce a balanced budget. Storti commented on the strength of the college's financial position provided by the college's prudent fiscal planning and enrollment management practices. Since 2013-14, PCC has increased its enrollment of full-time equivalent students — the state's metric for tuition apportionment — by 12.9 percent. Although the state is making available more resources for community colleges this year, Storti said, increased costs and economic uncertainties threaten to impact the college's bottom line. Projected net increases in general revenue of nearly \$1.76 million are offset by increased net expenses of \$1.77 million, Storti said. For facilities and equipment, the college expects balances in capital improvement accounts to decrease significantly during 2017-18 as projects are completed and funds are spent down. The board unanimously approved the 2017-18 tentative budget.
- Human Resources Vice President Lisa Norman presented the district's Equal Employment Opportunity Plan, a document outlining recruitment, hiring, and human resources practices to enhance staff diversity. Using a metric known as the "80% rule," which compares different groups of employees to identify areas of underrepresentation, the report's analysis tracked changes in population over various job classifications from 2013 to 2016. For example, the proportion of faculty who were of Latino descent increased from 13 percent to 17 percent over those three years, and Pacific Islander adjunct faculty increased from one to five percent. The plan calls for a number of measures, from expanded online services to enhanced training for hiring committees, to help address concerns highlighted in the report. The board spoke favorably of the college's efforts to enhance diversity, including PCC's African American, Asian American/Pacific Islander, and Latino advisory committees, but said that much remains to be done to ensure PCC's employee population reflects that of its students. Fifty-one percent of PCC's students are Hispanic or Latino.
- The board approved a suite of curriculum changes, updating the college's catalogue and aligning it with requirements for degree programs.
- A memorandum of understanding between the college and the Faculty Association was approved, authorizing changes to the 2017-18 academic calendar that the board approved in December. The revised calendar includes one Flex Day on March 15, 2018, and identifies August 25, 2017, the Friday before fall classes start, as a day on which faculty are not required to attend.
- Dr. Vurdien paid tribute to Haroldine Gardner, who passed away last month after 54 years of service as a PCC employee. The college will come together to celebrate Haroldine's life next **Wednesday, June 14, at noon in Creveling Lounge**. All are invited.

- Trustee Osterling announced that on Monday, July 31, the Los Angeles County School Trustees Association will hold a meeting in Creveling Lounge, with L.A. County Supervisor Kathryn Barger as the keynote speaker. More details are forthcoming.

Subject: Board of Trustees meeting report, May 3, 2017

Hello:

In an effort to help the campus community stay informed about actions taken during governance meetings, I'm pleased to share a report from last night's Board of Trustees meeting.

- The board congratulated Trustee Jim Osterling for his completion of the Community College League of California's "Excellence in Trusteeship Program," which recognizes elected leaders who have committed to educating themselves on effective board governance.
- The board approved a series of student travel activities, including a trip for 140 students in the TRIO program to San Diego for college tours in August and another for 80 Upward Bound Math/Science students to attend a STEM retreat in Big Bear next month.
- The board gave the go-ahead to a transfer of more than \$3.8 million in funds into a new restricted account created to prepare for expected increases in pension costs over the next five to seven years.
- Two faculty hires and two more in Business & College Services were approved. David Machen (Speech Communications) and Mary Wahl (Librarian) were added to PCC's faculty, and Marina Minassian (Supervisor, Student Business Services) and Chedva Weingart (Executive Director, Fiscal Services) filled vacant management positions.
- Routine course-cleanups curriculum changes were approved in business, languages, and the library.
- During public announcements many members of the board congratulated Student Trustee Nune Garipian and Associated Students President Julia Russo on their pending transfer to universities. Russo will start at the University of California, Berkeley, this fall, and Garipian will join the Trojan Family at the University of Southern California.

Subject: Board of Trustees meeting report, April 19, 2017

Hello:

In an effort to help the campus community stay informed about actions taken during governance meetings, I'm pleased to share a report from last night's Board of Trustees meeting.

- The board approved an instructional trip for two courses in geology, 30J and 30K, to take place during June and July this year. Twenty-two students in the courses will travel to Zion, Bryce, and Capitol Reef National Parks in Utah, and Mesa Verde and the Grand Canyon in Arizona.
- In two personnel moves that received board approval, Thomas Berg was named the Nursing Simulation and Skills Laboratory Coordinator, and Javier Carbajal-Ramos was promoted from his position in college orientation programs to Assistant Director, Educational Partnerships and Programs.
- The board sent forward its votes for the California Community College Trustees Board, which is a policy body of the Community College League of California. In addition to seven incumbent members — Stephen Blum (a trustee of the Ventura County CCD), Laura Casas (Foothill-De Anza CCD), Stephan Castellanos (San Joaquin Delta CCD), Adrienne Grey (West Valley-Mission CCD), Andra Hoffman (Los Angeles CCD), Pam Haynes (Los Rios CCD), and Jim Moreno (Coast CCD) — the board submitted votes for Loren Steck (Monterey Peninsula CCD) and John Leal (State Center CCD). Trustee Wah described the vote as a push for more board representation from rural areas and northern parts of the state.
- The board heard a summary of the district's Technology Master Plan, which is expected to guide four years of investment in information technology at PCC. (The working draft of the plan is available on [the college's website](#).) The plan contains 36 recommendations, divided into the following areas:
 - 14 related to systems and process,
 - 10 related to training and support,
 - 7 related to maintaining state of the art technology, and
 - 5 related to disaster preparedness and data redundancy.
- During public announcements, Student Trustee Garipian shared that the Armenian Student Association will be hosting an event on the evening of Wednesday, April 26, in Westerbeck Hall, in remembrance of the Armenian Genocide. LA City College Professor Emerita Kay Mourdian will speak at the event, highlighting the effects the violence had on her mother, a genocide survivor.

Hello:

In an effort to help the campus community stay informed about actions taken during governance meetings, I'm pleased to share a report from last night's Board of Trustees meeting.

- The meeting was the annual joint meeting with PCC's Associated Students government. AS President Julia Russo and her executive board discussed their priorities for the year, including college affordability, transportation, open educational resources, and promoting diversity on campus. Many trustees offered words of encouragement to the student leaders for the role they play in representing the views of PCC's student body.
- The board approved updated policies governing three areas: Integrated Planning (Board Policy 3250), Institutional Effectiveness (3251), Shower Facilities for Homeless Students (5220). A fourth policy governing Standards of Student Conduct (5500) was tabled for further review, in order to ensure greater student involvement with the policy approval process.
- A new associate degree for transfer in film, television, and electronic media was approved for addition to the credit curriculum.
- The board approved the creation of a new accounting fund, Fund 69 — Internal Services, that would house one-time funding being set aside for future PERS/STRS obligations.
- A series of student trips, including travel that will take the Lancer Jazz Big Band to Reno and a group of student journalists to Sacramento, was unanimously approved by the board.

Subject: Board of Trustees meeting report, March 22, 2017

Hello:

In an effort to help the campus community stay informed about actions taken during governance meetings, I'm pleased to share a report from last night's Board of Trustees meeting.

- Many trustees, Academic Senate President Valerie Foster, and Duresa Hinika, president of PCC's Ujima student group, advocated for a resolution under consideration by the board that states support for undocumented students and establishes PCC as a safe learning environment. Upon the recommendation of the Senate President Foster, the board debated including a clause clarifying the procedure by which the college would respond to formal requests from law enforcement officials. The board ultimately approved the resolution as written, with a direction to legal counsel and the superintendent-president to speedily develop and disseminate information instructing the campus on the procedures for interacting with law enforcement officials.
- As part of the rescheduling of the election calendar, and in compliance with the California Voter Participation Rights Act, the board approved a change to its bylaws establishing the start and end dates of trustees' terms and the timing of the annual organizational meeting. As board members will now be elected in June of even years, their terms will begin on the first Friday of July, and the organizational meeting will be the first meeting in July. They also discussed the procedures to follow in the event of a tie result in an election.
- The board approved the retirement of three employees: Learning Assistance Center staffer Frances Avila, who has 20 years of service to the district, and custodians Benjamin and Maria Jimenez, who have 22 and 14 years of experience at PCC, respectively.
- A dollar increase in the student health fee, to \$20 per semester and \$17 per intersession, was approved.
- The board elected to table a vote on the slate for the California Community College Trustees board until April 19.
- Academic Senate President Foster reported that more than 500 faculty and staff attended the Spring Flex Day on March 9, and spoke of the positive feedback she and her colleagues have received regarding the day's events.
- Superintendent-President Vurdien reported that the college is hiring an independent consultant to evaluate the college's agreement with Metro, the transit agency, that provides U-PASS reduced-fare transit passes to PCC students. The consultant will issue a report on the program and possible recommendations at a future meeting.
- In his report to the board, Superintendent-President Vurdien spoke in remembrance of Vernon Brown, the husband of Trustee Berlinda Brown, who passed away on March 14. The meeting was adjourned in his memory.

The message is powerful and effective because administration is meeting with the students in small groups to reassure them that they are safe. Outreach has been powerful.

Mr. Hilsman said this college is a predominantly minority campus and the Board of Trustees is working on a similar resolution to what the Associated Students are doing.

Mr. Hilsman also mentioned transportation has been an issue for the students because of the major expense of the Metro Pass.
