

1 MEMORANDUM OF UNDERSTANDING

5 PASADENA CITY COLLEGE CALIFORNIA FEDERATION OF TEACHERS (PCC-CFT)  
6 LOCAL 6525

10 This Memorandum of Understanding (MOU) is entered into by and between the Pasadena Area  
11 Community College District (hereinafter referred to as "PACCD" or "the District") and the Pasadena  
12 City College California Federation of Teachers (hereinafter referred to as "PCC-CFT" or "the Union")  
13 Local 6525 PCC/CFT, in accordance with the Educational Employment Relations Act and the  
14 Collective Bargaining Agreement between the parties.  
15

16 SALARY

17 Effective July 1, 2024, and subject to approval by the Board of Trustees, each range of the Salary  
18 Schedule shall be **increased 1.07%** of the state-funded Cost-of-Living-Adjustment (COLA)  
19 designated for community colleges in the State Final Budget for the fiscal year of 2024- 2025.  
20

21 Effective upon approval by the Board of Trustees, all unit members shall receive a one-time off-  
22 schedule payment of ~~\$2,000.00~~ ~~\$3,500.00~~. This payment will not be subject to retirement withholding  
23 and therefore will not be considered reportable compensation for CalPERS/CalSTRS retirement  
24 purposes. Only unit members actively employed on the date of board approval will receive the one-  
25 time payment.

27 In the event that any other PACCD bargaining unit successfully negotiates an on-schedule ~~and or~~  
28 ~~any on-schedule~~ increase effective during the 2024-2025 fiscal year including any one-time off-  
29 schedule payment that is greater than the increase set forth herein, PCC-CFT shall be entitled to an  
30 equivalent adjustment of their Salary Schedule, retroactive to July 1, 2024.  
31

32 This MOU is subject to approval by the Board of Trustees. This MOU shall take effect upon its  
33 execution and approval by the Parties. MOU is non-precedential and may not be utilized as the basis  
34 for any current or future claim of past practice.

36 This Tentative Agreement does not modify the parties' rights or obligations under the current  
37 effective Collective Bargaining Agreement (CBA) or the Educational Employment Relations Act  
38 (EERA). It is non-citable, non-precedential, and shall not be relied upon as the basis for the  
39 establishment of any past practice.


