## 1 MEMORANDUM OF UNDERSTANDING 2 3 BETWEEN THE 4 5 PASADENA AREA COMMUNITY COLLEGE DISTRICT AND THE 6 7 PASADENA CITY COLLEGE CALIFORNIA FEDERATION OF TEACHERS (PCC-CFT) 8 **LOCAL 6525** 9 10 October 1, 2024 11 12 This Memorandum of Understanding (MOU) is entered into by and between the Pasadena Area 13 Community College District (hereinafter referred to as "PACCD" or "the District") and the Pasadena City College California Federation of Teachers (hereinafter referred to as "PCC-CFT" or "the Union") 14 15 Local 6525 PCC/CFT, in accordance with the Educational Employment Relations Act and the Collective Bargaining Agreement between the parties. 16 17 **SALARY** 18 19 20 Effective July 1, 2024, and subject to approval by the Board of Trustees, each range of the Salary Schedule shall be increased 1.07% of the state-funded Cost-of-Living-Adjustment (COLA) 21 designated for community colleges in the State Final Budget for the fiscal year of 2024- 2025. 22 23 Effective upon approval by the Board of Trustees, all unit members shall receive a one-time off-24 25 schedule payment of \$2,000.00-\$3,500.00. This payment will not be subject to retirement withholding and therefore will not be considered reportable compensation for CalPERS/CalSTRS retirement 26 27 purposes. Only unit members actively employed on the date of board approval will receive the one-28 time payment. 29 In the event that any other PACCD bargaining unit successfully negotiates an on-schedule and or 30 31 any on schedule increase effective during the 2024-2025 fiscal year including any one-time offschedule payment that is greater than the increase set forth herein, PCC-CFT shall be entitled to an 32 33 equivalent adjustment of their Salary Schedule, retroactive to July 1, 2024. 34 This MOU is subject to approval by the Board of Trustees. This MOU shall take effect upon its 35 36 execution and approval by the Parties. MOU is non-precedential and may not be utilized as the basis 37 for any current or future claim of past practice. 38 39 This Tentative Agreement does not modify the parties' rights or obligations under the current effective Collective Bargaining Agreement (CBA) or the Educational Employment Relations Act 40 (EERA).
