15 16 17 18 19 20	Pursuant to Article 32.3 of the 2020-2023 CSEA Chapter 777 Agreement, the Parties have agreed to an automatic reopener of Article 8 regarding salary for the 2022-2023 academic year. The Parties agree to the following adjustment to the Salary Schedule (see Appendix "A" of the Agreement) for the 2022-2023 academic year:
21 22 23 24 25	Effective July 1, 2022 and upon the approval by the Board of Trustees, each range of the Salary Schedule shall be increased by six percent (6.0%) percent as a Cost of Living Adjustment (COLA). Only unit members active on the date of board approval will receive the COLA.
26 27 28 29 30 31 32	Effective upon the date of approval by the Board of Trustees, all unit members will receive a one-time off schedule payment of \$2,500.00. This payment will be split evenly over two consecutive pay periods and will not be subject to CaIPERS withholding and therefore will not be considered reportable compensation for CaIPERS retirement purposes. Only unit members active on the date of board approval will receive the one-time payment.
33 34 35 36	Should any other PACCD bargaining unit successfully negotiate an on-schedule increase effective during the 2022-2023 fiscal year greater than that set forth herein, CSEA shall be entitled to an equivalent adjustment of their Salary Schedule, retroactive to July 1, 2022.
37 38 39 40	This Tentative Agreement does not modify neither Parties rights nor obligations under the current effective CBA or the EERA, is non-citable, non-precedential, and shall not be relied on as the basis for the establishment of any past practice.
