COUNTER PROPOSAL FROM THE 1 2 PASADENA AREA COMMUNITY COLLEGE DISTRICT 3 TO THE 4 PASADENA CITY COLLEGE POLICE OFFICERS ASSOCIATION 5 6 **September 29, 2025** 7 8 The collective bargaining proposals presented herein by the Pasadena Area Community 9 College District to the Pasadena City College Police Officers Association is expressly made pursuant to the Educational Employment Relations Act and the Collective Bargaining 10 Agreement between the parties. 11 12 13 The following articles shall be deemed to remain unchanged in the Collective Bargaining Agreement except as set forth below: 14 15 **ARTICLE 12** 16 **UNIFORMS AND EQUIPMENT** 17 18 19 12.1 The cost of the purchase, lease or rental of any distinctive uniform required by the District, 20 or other equipment, identification badges, emblems, and cards required by the District 21 shall be borne by the District. 22 12.2 The District shall provide each employee covered by this Agreement, at the 23 24 commencement of his or her employment, with such uniform and equipment as the District considers necessary for the performance of the employee's work assignment. The District 25 26 will provide each College Police/Safety Officers employed by the District with a safety vest. 27 Uniformed officers and detectives are permitted to wear external vest carriers, designated Model #GD2P00US0. 28 29 30 12.3 During each fiscal year, the District shall provide each unit member with an annual uniform and equipment allowance as follows: College Safety Officers: \$1400.00 and 31 Dispatchers: \$1000.00. Said uniform and equipment allowance shall cover the 32 33 replacement, upkeep and maintenance of the unit member's uniform and equipment during the period of employment with the District. The allowance shall be dispersed 34 as a reimbursement by the District. Reimbursement will be provided upon 35 submission of a dated purchase receipt within 30 days of the purchase. All 36 reimbursement requests must be submitted by the unit member to the District no 37 38 later than April 30th of the fiscal year. 39 [Note: Reject.] 40 During each fiscal year beginning after an employee has commenced employment in a 41 classification covered by this Agreement, the District shall provide each employee with an 42 annual uniform and equipment allowance as follows: College Safety Officers: \$1200.00 43 44 **\$1400.00** and Dispatchers: **\$800.00 \$1000.00**. Said uniform and equipment allowance shall cover the replacement, upkeep and maintenance of the employee's uniform and 45 equipment during the period of employment with the District. Employees shall receive 46 47 their uniforms and equipment through a District Authorized Purchase Order with two District chosen authorized uniform vendors for expenditure during the applicable fiscal 48

year that are approved by the Director of the Department or his/her designee. Purchase order requests must be submitted by the employee to the District within the fiscal year.

Upon termination of employment in a classification covered by this Agreement, the District may require the employee to return to the District any uniform or parts thereof and equipment in his or her possession. The District shall not be responsible for loss, destruction or damage to an employee's personal tools or equipment.
